

The Lynton & Barnstaple Railway Trust

Gift Aid Notes

You must pay an amount of Income Tax and/or Capital Gains Tax in the United Kingdom at least equal to the tax the Trust reclaims on your donation in the relevant tax year. (This is currently 28 pence in the £)

NOTES:

1. You may cancel the declaration at any time by notifying the Trust.
2. If in the future your circumstances change and you no longer pay tax on your income or capital gains equal to the tax that the Trust reclaims, you must cancel your declaration
3. If you pay tax at the higher rate you can claim further relief on your Self-Assessment return
4. If you are unsure whether your donations qualify for Gift Aid tax relief please ask your Tax Office for leaflet IR113 "Gift Aid".
5. Please notify the Trust if you change your address while this declaration is in force.

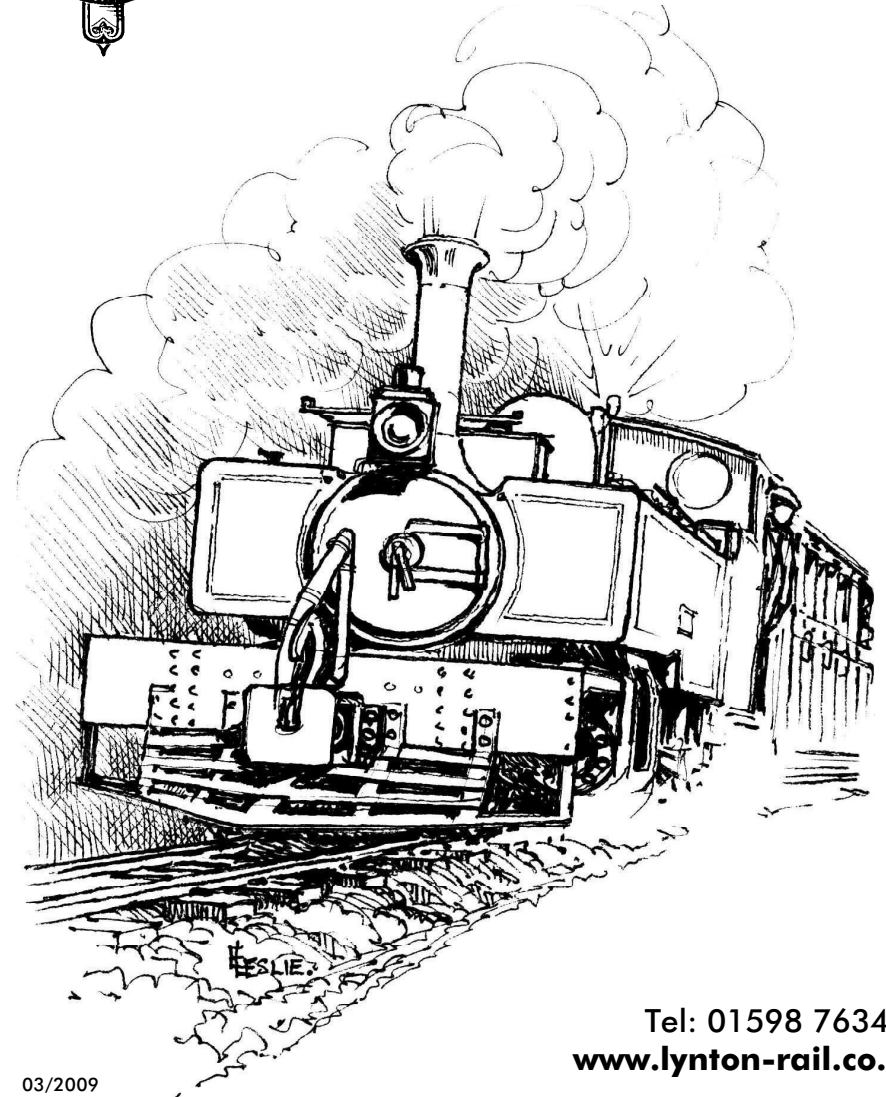
