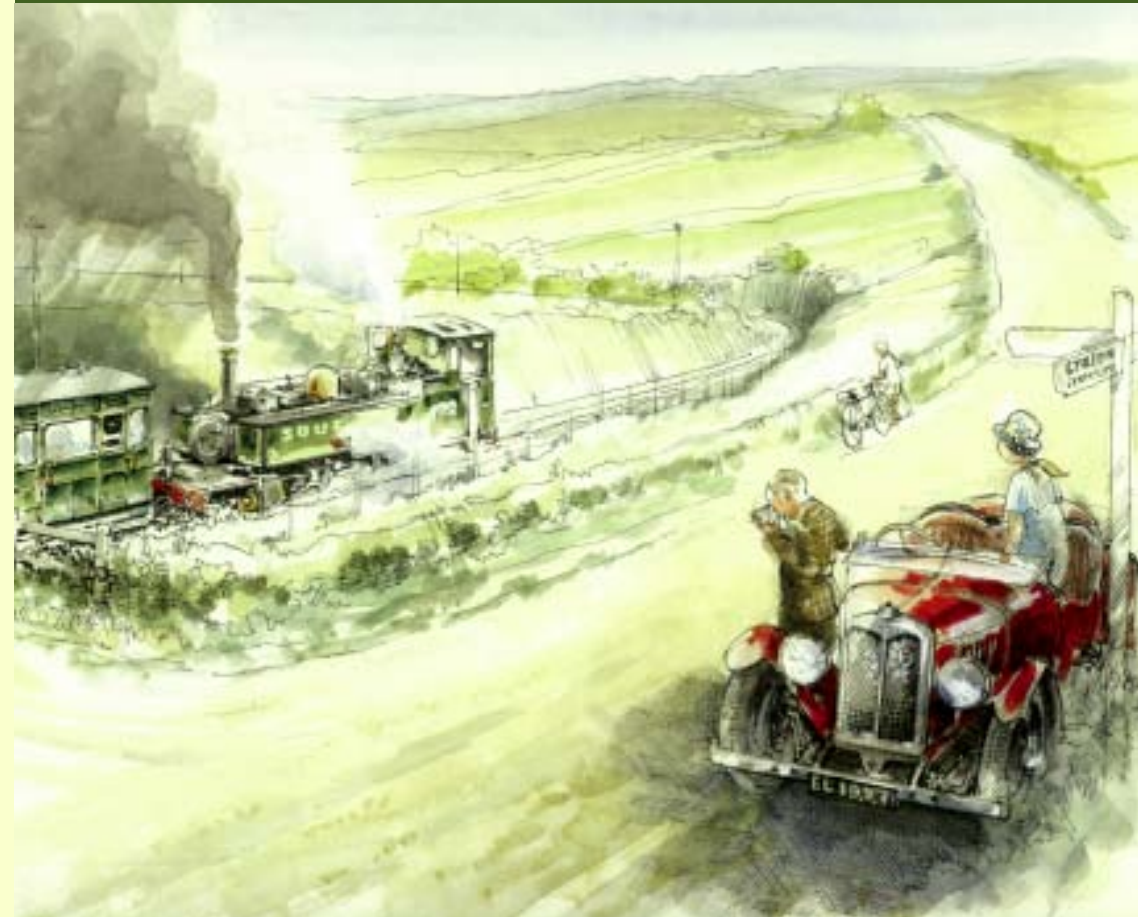

All this has to be done before we can prepare the trackbed, relay the rails and commence operating the Railway once more.

A **"reserve"** needs to be created so that the project can make opportunistic purchases of trackbed that might become available at short notice or other land of strategic advantage to the project.

The reconstruction of the Railway will not only broaden its appeal but also bring wideranging benefits to the community of North Devon as well as to South West residents and businesses generally. Just ask those who already live and work close to one of the many successful heritage lines such as the West Somerset, North Yorkshire Moors, Ffestiniog and Welsh Highland and many others.

There is no other similar project and your contribution is vital. Make the difference today and be a part of what everyone wants to see: a greater length of reopened L&B. The next train to Blackmoor Gate could be leaving very soon - help us get it on its way.
